I. EXPERIENCE

Director, Westchester Library System, Ardsley, New York.

Dates of Employment: 1982 - 2005

The *Director* reports to the Westchester Library System Board of Trustees, a 15-member lay Board elected by the trustees of the 38 member public libraries.

Principal Responsibilities: management of a cooperative library system (staff of 50), serving 38 member public libraries and a population of 923,000; County-wide political relations, technology, public relations, and development work; library spokesperson for Westchester libraries; services included information technology planning and implementation; children, young adult, adult, media, administrative, collection development, and reference consultation services; and, responsible for several grant supported projects, including the development of a video and cable communications program, correctional institution services, and a variety of outreach services to citizens with special needs, an outstanding job and career counseling service, and interlibrary loan service to the County's 38 public and 15 academic libraries. Also negotiated contracts with vendors.

Information Technology & Automation: Responsible for the automation of the Westchester Library System and its member libraries; responsible for the planning, development, implementation and management of a 700 terminal / 44 site online circulation, public access catalog, Internet gateway, and online database system serving

all 38 public libraries of the Westchester Library System and the Bedford Hills Correctional Facility. Its 44-site network is the largest in Westchester County. Also raised over \$2,000,000 in local support for the information technology and automation program by meeting with local trustees, city and town officials, and others.

Budget and Interagency Relations: Full budget, managerial and planning responsibility for County-wide public library services; worked closely with the County Executive and the County Board of Legislators to increase County support from \$40,000 in 1982, to a high of \$940,000, an especially noteworthy achievement for WLS, a State agency. As President of the statewide Public Library System Directors' Organization, led a successful lobbying effort which culminated—for the first time—in New York State's providing annual automation support to each of the State's public library systems.

Public and Community Relations: Has hosted a monthly cable interview show since 1994 years with celebrity and other notable guests from the community, as well as a weekly radio show, as part of a multimedia public and community relations campaign to increase the visibility of public libraries and the public's awareness and support of library services. Guests have included such luminaries as Arthur Ashe, Roger Kahn, Paul Schrader, Maurice Sendak, Alan Arkin, Esmeralda Santiago, Lee Archer, authors, government officials, business leaders and others. Began an Annual Book & Author Luncheon with the sponsorship of Consolidated Edison, the Gannett Suburban Newspapers, H. W. Wilson Foundation, the American Booksellers Association and others. Initiated an annual African-American Authors and Readers Literary Tea sponsored by Fleet Bank. Member of numerous local and regional organizations. Both events have been extremely successful.

Personnel Administration: As director was responsible for personnel policy, and personnel administration. Performed a complete classification study which culminated in all of the recommendations being approved by the Board of Trustees and implemented. Completely rewrote and codified the *Personnel Handbook*. Developed a layoff policy and set of procedures which serve as a model for many libraries, as has the *Personnel Manual*.

Associate Professor, School of Library Service, Columbia University. 1977 - 1982. As a member of the faculty, taught, researched and published in the area of technical services, cataloging, information technology and automation, and public library service. Advised students, and participated in a number of appropriate activities including membership on several faculty committees. Participated in professional meetings, conferences, etc.

Coordinator of Technical Services, The Branch Libraries, The New York Public Library. 1974 - 1977.

Had chief responsibility for the acquisitions, cataloging, and processing and binding of approximately 500,000 books, records, tapes and other non-print materials; and,

managerial responsibility for 100 staff. Worked closely with the Library Information and Online Systems Office (LIONS) to ensure that the automated cataloging system worked properly; planned in conjunction with LIONS for further development and implementation of automated systems for the Branch Libraries. Was a voting member of the Branch Libraries' chief policy making body, the Council of Coordinators; was a voting member of the Advisory Board, which made recommendations on such personnel matters as in-service training, promotional eligibility, etc.; and was the Council of Coordinators representative on the Branch Libraries Non-Print Media Committee.

Director, Technical Services Division, Hennepin County (MN) Library. 1969 - 1974.

Had chief management responsibility for technical services which included acquisitions, cataloging, processing and circulation as well as all automation planning, development and implementation; and also participated in the overall management of the Hennepin County Library. Had management responsibility for 60 people. In the years 1970 - 1974, production more than doubled; two automated systems were installed (one for acquisitions and one for cataloging—there were no integrated systems at the time); and innovative and unique applications of information technology were developed and implemented for the full range of print and non-print materials. This included the transfer to Hennepin of the MARC-based catalog conversion programs developed at the University of California's Institute of Library Research, and the automated cataloging and authority control system developed by The New York Public Library. Through these efforts the entire catalog was automated and the basis established for an award-winning and arguably the most creative approach to cataloging and serving library users.

Manager, Library Processing, Information Dynamics Corporation (IDC). 1968 - 1969.

Had profit and loss, as well as supervisory responsibility, for acquisitions, cataloging, and processing of materials and preparation of information for computer input for libraries on a contract basis. Customers included the NASA Electronic Research Center (Cambridge MA), Polaroid Corporation, and others. Planned and managed all automated and manual processing activities in the 25-person Library Systems and Services Division.

Participated in the design, organization and implementation of all new automated processing systems. Did management analysis and consulting in library operations. In concert with IDC systems analysts, developed and utilized data processing and computer-output-micrographic systems. Participated in the development and application of IDC's pioneering use of microform-based cataloging systems, particularly the integration of the micrographic, data processing, and photoduplication technologies that resulted in the *Micrographic Catalog Retrieval System (MCRS)*. IDC is now defunct.

Administrative Officer, then promoted to Executive Assistant, Processing Department, Library of Congress. 1966 – 1968.

Responsibilities were primarily in the areas of fiscal and personnel administration, space planning and utilization, and management analysis, all of which were focused on the largest technical services operations in the world. As a special assistant, worked closely with the Director of the Processing Department in organizing and establishing the Pre-1956 National Union Catalog Publication Project, the editing for publication of the 18

million card, *Pre-1956 National Union Catalog*; and in organizing and establishing the **National Program for Acquisitions and Cataloging (NPAC)**, the Shared Cataloging Division and, in effect, centralized cataloging internationally.

As the chief internal controller of the Department, was responsible for controlling and analyzing the Processing Department's \$16,000,000+ budget. Had a key role in the administration of all personnel activity for the 1,500 people on the Processing Department staff. Served as a national recruiter for professional staff for the Library of Congress. Performed management studies as required.

Was promoted from the classification of GS-7 to GS-12 in less than two years of service at the Library of Congress. The length of time in service for the three promotions (7 to 9 to 11 to 12) was without precedent at the Library of Congress and probably elsewhere in the Federal service.

Assistant Head, African-Asian Exchange Section, Exchange and Gift Division, Processing Department, Library of Congress, 1966. Served as second-in-charge of the Library of Congress's exchange programs with hundreds of institutions, governments, agencies and educational organizations on the continents of Africa and Asia. Left this position at the invitation of the Processing Department's Executive Officer to assume the position immediately above.

Intern, Special Recruit Program for Outstanding Library School Graduates, Library of Congress, 1965 - 1966. Was one of fourteen people selected for this honor from all of the library school graduates in the United States, in 1965. For a six-month period worked in the major reference and technical services operations of LC, and also toured or worked in all of the other departments of the Library.

Searcher, Graduate Theological Union Bibliographical Center (Berkeley, California). 1965. Did bibliographical searching of orders for a consortium of San Francisco Bay Area theological libraries while in library school.
